Tuesday, February 17th, 11am-2pm

This Tuesday, February 17, the Santa Barbara County Board of Supervisors will be hearing the staff report on the CalTrans grant prepared by both County and City Staff for adoption. We would urge all those in our Association who are supporting this project to attend the meeting. We understand that the issue will be heard sometime between 11am and 2pm.

The opposition is going to turn out in full force and depict it as a project that will "destroy" the corridor rather than provide all of us with a safe way to use the corridor and at the same time honor, retain, and promote all of the cultural heart of who we are as Santa Barbara.

District Elections

Saturday, February 28th

The City will hold a community workshop on Saturday February 28th to introduce members of the public to the issues of district elections. The public may provide input online or to the City Clerk's Office between February 28 and March 13. A second community workshop will be held on March 18th in the evening to introduce the results and conclusions gathered through public input. Members of the public will also be able to provide additional comments.

7-Eleven ABC Update

The beer and wine liquor license for the 7-11 under construction at Mission & State has not been finalized according to Melissa Rice, Licensing Rep. II, Department of Alcohol Beverage Control, Ventura District Office, (805) 289-0104 Melissa.Rice@abc.ca.gov

The ABC received 36 protest letters, including one from the City Police Department which recommended approval with conditions. It seems likely that ABC will place conditions on the times of day beer and wine can be sold, as well a restriction on single-unit sales. Once Ms. Rice completes her investigation, those who submitted a protest will receive a letter from ABC stating the conditions on sale of beer and wine that will be imposed on 7-11's liquor license. We will of course give you an update in the newsletter.

RV Parking in the Upper East

The Board has formed a subcommittee to take a closer look at the occurrence of RV parking in the Upper East and what the city is doing to address this problem. The current law allows any RVs, boats, trailers, large vehicles or cars to park on the street for up to 72 hours without being moved. Unfortunately, the persons who are using our neighborhood to 'live' know the rules and move their vehicle/home to avoid getting ticketed. The subcommittee will be monitoring the calendar of the



City Ordinance Committee so we can attend the hearing regarding 'Excessive RV Parking'. We will let you know when we learn of that hearing. Here's a <u>link</u> to the City Attorney's report presented at the November 18th Ordinance Committee meeting.

Upper East History – George Washington Smith in the Upper East

In 1917 Mr. George Washington Smith moved to Montecito from Philadelphia to retire from a successful career in bond trading and devote more time to painting. As it turned out, he ended up founding the Spanish Colonial Revival architecture movement. He had bought a piece of land in Montecito, then designed and built a home for himself based in the style of Andalusia farmhouses he had observed during travels in Spain.

It is said that the locals were more interested in Smith's architectural designs than his paintings, and clients started commissioning him to design their own homes. For the most part located in Montecito, these beautiful houses are still very much appreciated, and some are quite well known. George Washington Smith passed away after just

twelve years of creativity in his new field, but his legacy formed the foundation of local Santa Barbara and Montecito architectural history.



The Upper East boasts some outstanding examples of the architecture of George Washington Smith. One is the "Frothingham"

House" at 232 Los Olivos; it typifies Smith's preference for thick stucco walls, deep window reveals, handmade terra cotta roof tiles, and generally spare ornamentation. Another very beautiful example is at the upper end of Plaza Rubio at number 530. The house at 2401 Garden Street was also designed by Smith, but in a style atypical for him, namely that of a large English cottage.
