New officers for the UEA board will be selected at our January 10th board meeting.

The change in corporate status to a nonprofit public benefit corporation under 501c(3) of the IRS code was approved by the membership. This will reduce State fees for the UEA and thus lower our operating costs. The assets of the Association will continue to be devoted to the public benefit.

Walking With Mo

This newsletter will arrive at your computer/phone after January 1st, but we welcome everyone to a new year in our Upper East neighborhood. By the way when this was written, Mo was lurking around the Christmas tree and very busy.



As for two of our most important efforts, we will see what the next steps are regarding the City's enforcement of the vacation rentals ordinance and of RV parking on our narrow streets. For those of you who were able to attend our annual meeting, our City Attorney, Ariel Calonne, provided us with a status report on both, particularly the challenges ahead in enforcing the new Over Sized Vehicle Ordnance that went into effect December 16, 2016. Both of these ordinance enforcement

efforts will start to play out in the next few months. In regard to RV parking, the City will have to complete the installation of signs across the city defining the limitations of RV parking, and they will have to complete the development of a process for permits and appeals. Please continue to report RVs parked on our residential streets using the link on our website http://sbuppereast.org/

The vacation rental ordinance actually has existed for some time, and at the direction of City Council, the staff is in the process of hiring and training additional enforcement personnel. Action has started against some of the biggest offenders of the vacation rental ordinance, but as with most governmental processes this may take some time.

This year of 2017 will see our neighborhood's first participation in City district elections. We are in District 4 and we will begin identifying potential candidates. We have established preliminary discussions with members of the boards of our adjoining neighborhood associations and hope to be able to announce some events for candidates' forums and other activities.

Thanks for all your continued support and participation in helping maintain our neighborhood and a special thanks to board members and committee volunteers who continue to provide service to all of us.
