Santa Barbara's Historic Upper East Neighborhoods

The centerpiece of the Upper East neighborhood is the Old Mission Santa Barbara, National Historic Landmark. Since 1960, the City of Santa Barbara has had in place a landmark district called El Pueblo Viejo. That was later supplemented by designating an area around Old Mission Santa Barbara and referring to it as El Pueblo Viejo II (EPVII). In addition to preservation of landmarks, the cohesiveness of the area is achieved by design review of exterior alterations only. Any alteration must be compatible with the California Adobe, Monterey Revival and Spanish Colonial Revival styles. The City is now considering revising the Historic Structures Ordinance (SBMC Chapter 22.22) language that might be of interest to many of our membership. It is also considering adding ordinance provisions to facilitate designations for historic and special design districts within the city.

Special Design District Definition

A "Special Design District" is a geographically defined area of the City selected for the purposes of maintaining design standards for neighborhoods, visual corridors, cultural landscapes, and/or major hillsides to promote architectural compatibility of buildings and structures, neighborhood preservation goals, sensitive grading design and/or appropriate levels of landscaping."

The Community Development Department's Planning Division is recommending two additional Historic Districts that would impose a design review process to protect the historic resources of the area.

The "Mission Gardens Potential District" includes the residences in the 300 Block of E. Padre Street and 300 E. Mission Street that were recommended as a Historic District in the Lower Riviera Historic Resources Survey. The 33 additional properties are located on either side of Roosevelt Elementary School, as shown in yellow on the map.

The "Plaza Bonita Potential District" is located on the Lower Riviera. The ten parcels proposed to be considered a historic district center on the cul-de-sac of Plaza Bonita, based on the recommendations of the Lower Riviera Historic Resource Survey. It is shown in green.

In addition the City has an existing Mission Area Special Design District that extends an additional 1000' around the existing EPVII boundary from the Old Mission (outlined in blue). The City is considering clarifications and clear design criteria for this Mission area that will be part of the Ordinance Committee discussion. This area is shown as a blue line extending 1000' beyond the EPVII.

The City is also recommending additional individual designations or other protection mechanisms due to the presence of many structures that have been determined to have historic significance, shown in red on the figure.

The UEA will continue to attend each of the Ordinance Committee sessions that will address these proposed changes and additions. We will also continue to keep or membership informed of this issue. 


Garden Street —The Path Extending from the Presidio's Huerta (food garden) to the Old Mission's Huerta

When Santa Barbara was a Spanish town, before the Americans laid out the street grid system, paths linked it together. Officially named in Haley's 1851 survey, Garden Street is one of Santa Barbara's oldest streets. It was also called *Jardines* (Spanish for "gardens") on early maps. This reflects the fact that it passed through the area around Cota and Ortega Street known as the Presidio's *La Huerta*. Tourists can visit a demonstration 'huerta' located behind the Santa Barbara Trust for Historic Preservation's Presidio kitchen.

If you would like to see *La Huerta* Historic Gardens at the Old Mission, they are open to the public each Wednesday, 9am to noon. Entry is from the Old Mission's public parking lot at the end of Laguna Street, through a path lined by the Stations of the Cross. Oversized Vehicle Parking Issue

The Upper East Association Board has closely monitored the current RV parking situation in our neighborhood. At the June 7, Special Ordinance Committee Meeting, which Fred Sweeney and Steve Forsell attended, the committee voted 2-1 to choose Option Two, as presented by City staff. Much of the discussion centered on safety issues as well as citizen complaints regarding RV parking on their streets. This option is scheduled for City Council consideration on October 18, 2016.

Option Two creates a citywide ban on all oversized vehicle parking, subject to a series of special circumstance exemptions. In general, oversized vehicle means any vehicle which exceeds 25 feet in length, or 80 inches in width or 82 inches in height. Staff believes that this prohibition would encompass many RVs. Posting signs would be required. There would be several exceptions for the ordinance to be workable and practical. These exemptions include oversized vehicles engaged in loading and unloading, or any government vehicles, or public utility vehicles, or oversized vehicles displaying a valid disabled placard or license plate. Any portion of the proposed ordinance may be changed by the full City Council. Your Upper East Association Board will continue to monitor the situation and update our membership.
